## 1. Title of the Practice

Regular conduction of student centric activities

#### 2. Objectives of the Practice

A student centric activity is one that keeps students in centre and employs learning strategies that focus on students and are student-friendly. The institution employs a student centric activity such as organization of workshops, seminars, poster presentation, publishing wall magazines, festivals, special days, educational tours career counselling and personality development sessions, sports, games etc. Seminar is always a forum from which students can develop scientific culture and enhance their aptitude in the subject. By poster presentation, the thought processes and creativities of students are presented. The NCC and NSS activities make students sensitive towards their duties and responsibilities within the society and community. The objective of such programs is to create a diverse and relevant spectrum of departmental activities and to merge those towards a common institutional goal. These activities develop the goal of education through various skills like soft skills, leadership skill and team building skills and strengthen the connection between a student education and the world they live in.

## 3. The Context

The beginning of the year 2020 was marked by a major global public health crisis. In this context for effective teaching-learning process ICT enabled tools were largely used for enhancing academic excellence. Google classroom, Google form, online platforms such as Google-meet, zoom, webex etc. were mostly used for effective Teaching – Learning process during the Covid- 19 pandemic. All the departments provided online study material to ensure that students do not face any problem to collect or purchase books in the pandemic situation. Co-curricular activities are complementary to the learning process and are often created through a common charter of the academic institution to promote student centric activities. Each department endeavours to build customized activities which make the students more inclusive as well as participative. Augmented participation of students and the teachers of the departments were made a priority measure of impact in these activities.

- Department of Journalism and Mass Communication organized a national webinar on " Development Communication and Social Media" on July 10, 2020
- Department of Journalism and Mass Communication organized a national webinar on " Fake and Propaganda News Coverage in Media " on July 11, 2020
- Department of Electronics in association with Department of Physics, Computer Science and IQAC organized a 3-day Global E-workshop : Aspire Learning on 3<sup>rd</sup> 5<sup>th</sup> July, 2020
- Department of Physics in association with Department of Computer Science, Electronics and IQAC organized a one-day national level webinar on "Use of ICT in Teaching Learning During Pandemic and Post Pandemic situation" on 13<sup>th</sup> July, 2020.

In earlier years, we have witnessed limited student participation in these workshops, seminars, debates, wall magazines, cultural programmes, excursions etc. student centric activities. Presently, student participation in such activities has substantially improved. Overall organizational participation has increased and awareness has been raised among them regarding the involvements and usefulness in these activities. ## 2. Objective

- To organise college/regional/state/national/international level webinars and workshops in the college, independently as well as through collaborating with scientific organizations, other research bodies and other college
- To expose students of the college to research skills and methodologies through student project work and to encourage them to pursue a research career through regular webinars, talks and workshops.

## 3. The Context

The college has extremely talented faculty members who are very keen to pursue their academic and research activities in the college. The college has set up a Research subcommittee to chalk out institutional strategies for planning, upgrading, creating and providing infrastructural facilities to meet the need of researchers. The Research subcommittee of the college implements various strategies to encourage and support a research friendly atmosphere and facilitate an active research agenda and profile of the institution.

## 4. The Practice

The institution encourages and extends all help possible to promote research activities and a thriving research culture in the institution. The measures taken by the institution to achieve this aim are as enumerated below :

## 5. Evidence of success

The positive impact of this practice of the institution to inculcate a flourishing research culture among the faculty of undergraduate college is evident in the data given below :

- Total number of 26 [14 in Science and 12 in Humanities and Social Sciences] papers were published by the faculty members in the Journals notified on UGC website during the year.
- Total number of 62 [26 in Science and 36 in Humanities and Social Sciences] books and chapters in edited volumes/ books were published and papers were published in national/international conferences proceedings.
- The topics of these 26 papers and 62 books/ chapters in edited volumes/ books covered scientific theoretical aspects, social, environmental, cultural, political, and above all Covid 19 related aspects.

# 6. Problems encountered and resources required

• Due to Covid – 19 Pandemic, the session 2020-2021was very difficult for the faculty members to pursue their research activities.

- Non availability of sufficient financial resources.
- Faculty members find insufficient time for research activities due to the teaching responsibilities and commitments of an undergraduate college.
- Limited opportunities for undergraduate students to get involved in research work/projects

# 7. Resources required

- Identification of funding opportunities and research grants / fellowships available from funding agencies like UGC, DST, DBT, CSIR etc.
- Upgradation and digitization of the library is the need of the hour, as online access to journals and subscription to e-journals is urgently required to support faculty in their studies and research work.
